Attention of all concerned is drawn to the contents of the Master Circular No. BCD/4429 dated 01.02.2012 on Schedule of Bank Charges in respect of iBanking Charges of the Bank.

In this connection, considering the request of various tiers as well as to popularize the iBanking service of the Bank, the Management has re-fixed the iBanking Charges as under:

Sl No.	Name of Services	Approved Charges
01.	iTransfer (Fund Transfer)	Tk. 0.25 per thousand but Minimum Charges: Tk. 5/- and Maximum Charges: Tk. 100/- only (VAT as per govt. rule).
	iTransfer Limit	Tk. 5.00 Lac (maximum).
	iTransfer to MSS/ MMS/ MHS/ MWCD Account	Free
	iTransfer of Staff Salary & Allowances	Free
	iTransfer (Account to Account) within a Branch	Free
02.	iRecharge	Free


However, rate of all other charges as contained in the Master circular mentioned above will be unchanged.
