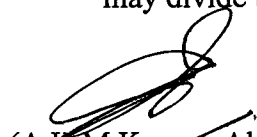

NOTICE INVITING TENDER

ISLAMI BANK BANGLADESH PLC invites sealed Tenders from bonafide Bangladeshi Interior Contractor(s) having wide experience in Internal Construction, interior and other related works for performing of Internal construction, interior and other related works under the following conditions:

1. Name of work: Internal construction, interior and other related works of proposed (i) Potherhat (Rural) Branch, Chattogram, (ii) Laxmipur (Urban) Branch, Rajshahi & (iii) Gangni (Rural) Branch, Meherpur.
2. **Eligibility:** Specialization in the related field and having past experience in completion of similar works at Bank and its allied concern of minimum Tk.20.00 lac in a single tender. 4. **Earnest Money:** 2.5% (two point five percent) of the total Tender amount in favour of Islami Bank Bangladesh PLC in the form of Bank Draft/Payment Order from any Scheduled Bank preferably from any branch of Islami Bank Bangladesh PLC must be submitted along with the Tender without which the Tender shall be rejected outright.
