1. **Name of work:** Procurement of 12,00,000 units EMV CHIP CARD (4,50,000 units EMV VISA DI Card, 5,50,000 units EMV MASTER CARD DI & 2,00,000 units EMV UPI DI) for the Bank. Detailed specification is mentioned in the Tender Schedule.
2. **Eligibility:** The intending bidders have to apply in their letter head pad and must submit documentary evidence like VAT registration Certificate, Up to date Trade License & TIN Certificate, Authorization letter from OEM duly issued by the Head office directly or by the regional office of the OEM/Dealer/Distributor in case of reseller for delivering of the related item, Certificate in support of their past experience and specialization in the field. On being satisfied with documents submitted by the applicant, Tender document will be sold to the intending bidders.
