Sub: Comprehensive Circular on Schedule of Bank Charges for General Banking, Investment and Foreign Exchange portfolios of the Bank.


Attention of all concerned is drawn to the above subject that the Board of Directors of the Bank, in its 303rd Meeting held on 19.09.2021 approved the revision of the Schedule of Bank Charges as per Annexure- A, B & C regarding General Banking, Investment & Foreign Exchange portfolios respectively (enclosed herewith). All previous circulars in this regard except Circular Letter No. BCD/4954 dated 06.03.2013 regarding Charges of BACH and Instruction Circular No. IBBL/HO/ABW/2021/1791 dated 06/05/2021 regarding Schedule of Charges of ADC related products & Services of the Bank are superseded by this circular to comply the Master Circular on Schedule of Charges of Bangladesh Bank, BRPD Circular No.11 dated 10 June 2021.

Mentionable here that BRPD Master Circular No.11 has been issued superseding 08 BRPD Circulars (No. 19/2009, 09/2010, 19/2010, 30/2010, 02/2017, 09/2018, 07/2019 and BRPD Circular Letter No. 02/2020) but upholding the instruction of BRPD Circular Letter No. 21/2021.


Besides, it is also instructed by the said circular to open account with initial/minimum deposit of Tk.1,000/- for Current Account and Tk.500/- for Savings Account. But to open special privileged account there is no obligation of the initial/minimum deposit.

Notable that in case any item of this Schedule does not meet regulatory directives, the same shall stand modified accordingly to ensure compliance.

All concerned are, therefore, advised to realize the Revised Charges/Fees/Commissions including VAT as per mentioned rate in the Annexure- A, B and C with immediate effect and to display the Revised Schedule of Charges including VAT in the Notice Board of all Branches, Sub-Branchees and Agent Outlets to bring it to the notice of our valued customers and other stakeholders.
