The Tenderers must submit their offers in Duplicate; two sealed envelopes-one marked "Original Offer" for Supply, Installation, Testing and commissioning of "Passenger Lift" and the other marked "Copy Offer" for Supply, Installation, Testing & Commissioning of Passenger Lift. The technical part should contain the technical specifications of the equipment/materials supported by catalogues of required categories only and the financial part should contain the price as per schedule of items of works. The financial offers should contain rate and price of the offered item in item wise.
4. Earnest money amounting to Tk.3.0 (three) lac only must be submitted in the form of Bank Draft/Pay order from any scheduled Bank of Bangladesh in favor of Islami Bank Bangladesh Ltd. with the Technical Offer without which the tender shall be rejected.
