NOTICE INVITING RE-TENDER FOR SALE (CENTRAL AC 300 TonsX2)

Sealed Tenders are hereby invited by Islami Bank Bangladesh Limited from interested parties/ companies for selling Central AC Plant and all of its auxiliary and ancillary units (300Tx2 units, Carrier-USA) installed and commissioned on November 20, 1999 at Islami Bank Head Office, Islami Bank Tower 40, Dilkusha- Dhaka-1000 under the following terms and conditions:

1. The intending Bidders have to apply in their letter head pad for purchasing the Central AC plant and must submit the documentary evidences supporting their past experience in this line.
2. Tender Schedule will be provided from CSD, IBBL Head Office at Amanullah Bhaban 7th Floor, 63, Dilkusha- Dhaka from April 05, 2017 to April 30, 2017 during Office hours from 10:00 A.M to 5:00 PM on payment of Tk.3,000/-(three thousand) only in cash (non refundable).
3. Tenders will be received at the office of the undersigned from April 06, 2017 to May 03, 2017 during Office hours from 10:00 A.M to 3:00 PM and will be opened at 3:20 PM on May 03, 2017 at the same place in presence of the Bidders or their representatives who may like to attend at the time of tender opening.
4. Islami Bank Bangladesh Limited reserves the right to accept any tender and reject any or all tenders without assigning any reason whatsoever.
5. 10% (ten percent) of the quoted price of Central AC Plant should be submitted in the form of Bank Draft/Pay Order from any scheduled Bank of Bangladesh (preferably Islami Bank Bangladesh Limited) must be submitted along with Tender documents as Earnest Money without which the Tender shall be rejected outright.
6. Rest of the quoted price (90%) of qualified bidder must be submitted in the form of Bank Draft/Pay Order from any scheduled Bank of Bangladesh (preferably Islami Bank Bangladesh Limited) within 07 (seven) days after written information from the Bank before taking delivery of the AC Plant.
7. The qualified bidder shall also submit VAT & Tax (@ 5%+4%) = 9% separately on the quoted price at the time of paying 90% price before taking delivery of the AC Plant.
8. It may take some time to make delivery of the Plant due to some unavoidable circumstances related to the Official formalities for this unwanted delay no claim will be entertained from the Bank side.
9. No Ducting will be supplied with the Central AC.
10. The earnest money of the unsuccessful bidders will be refunded without any profit after finalization of the issue with the highest bidder.
11. The earnest money of the successful bidder (highest) bidder will be forfeited in case of failing to submit the remaining (90%) price of the quoted amount along with the VAT & Tax within the stipulated time as mentioned in clause-6.
12. Site visit is open and available for the intending bidders only from 11:30 A.M to 12:30 P.M on each office day.
13. Any persuasion / syndication / canvassing directly or indirectly in connection with the Tender is strictly prohibited.
