Sealed Tenders are hereby invited by Islami Bank Bangladesh Limited from reputed Manufacturers / Local Agents for Supply, Installation, Testing & Commissioning of the following works:

In case of 3 Phase standby Diesel generator 150, 100 & 50KVA: Engine must be Komatsu (Japan) / Perkins (UK) / Cummins (USA) / Mitsubishi (Japan) / Volvo (Sweden) / Cater Piller (USA) and Alternator must be Newage Stamford (UK) while the port of shipment must be Japan, USA, UK. In case of 3-phase standby Diesel Generator 20 & 30 KVA: Engine must be Perkins (UK) / Cummins (USA) / Mitsubishi (Japan) / Isuzu (Japan) / Nissan (Japan) / Volvo (Sweden) / Duetz (German) / Kubota (Japan) and Alternator must be Newage Stamford (UK) / Leroy Somer (France) / Denyo (Japan) while the port of shipment must be Japan, USA, UK.

The intending suppliers have to apply in their letter head pad and must submit documentary evidence like up to date Trade License, VAT registration Certificate, Up to date Tax clearance certificate, Distributorship/ Local agency of the mentioned item. Manufacturer must submit trade license where it will be clearly mentioned that they are the manufacturer of the item to be offered. Experience Certificate/Performance Certificate (at least for last 05 years) of the company from local clients. **On being satisfied with the documents submitted by the applicant, Tender Schedule will be sold to the intending Bidders during office hours from October 12, 2014 to October 20, 2014 on payment of Tk.2,000/- (two thousand) only in cash (non refundable). No Tender document will be issued/ received by mail.**
2. Tenders will be received at the office of the undersigned up to **3:00 PM on October 22, 2014** and only Technical Offer will be opened **at 3:15 PM on** the same date and same place in presence of the suppliers or their representatives who may like to attend at the time of tender opening.
