

NOTICE INVITING TENDER

ISLAMI BANK BANGLADESH LIMITED invites sealed Tenders from bonafide Bangladeshi Cleaning Contractor(s) having wide experience in cleaning services and related works under the following conditions:

1. **Name of work:** Selection of Contractor related to cleaning services of different Department / Divisions of Head Office in 2-packages situated at (i) Bank's own premises of 40 Dilkusha, 28 Dilkusha, 196 Motijheel & Hot DRS at Kakrail, Dhaka and (ii) rented premises of 75 Dilkusha, 39 Dilkusha, 43 Dilkusha, 63 Dilkusha, 20 Dilkusha & 14 Dilkusha, Dhaka for 2 (two) years.
