

NOTICE INVITING TENDER

ISLAMI BANK BANGLADESH LIMITED invites sealed Tenders from bonafide Bangladeshi Interior Contractor(s) having wide experience in Internal Construction, shifting and related works for performing of (i) Internal Construction, renovation, shifting and other related works for accommodation of Internal Control and Compliance Wing (ICCW) at 5th & 6th floor of 39, Dilkusha C/A, Dhaka, (ii) Internal Construction, shifting and other related works of Kaliganj Branch, Jhenaidah and (iii) Internal Construction, renovation and other related works of Benapole Branch, Jessore under the following conditions:

1. **Name of the works:** (i) Internal Construction, renovation, shifting and other related works for accommodation of Internal Control and Compliance Wing (ICCW) at 5th & 6th floor of 39, Dilkusha C/A, Dhaka, (ii) Internal Construction, shifting and other related works of Kaliganj Branch, Jhenaidah and (iii) Internal Construction, renovation and other related works of Benapole Branch, Jessore.
2. **Eligibility:** Specialization in the related field and having minimum 05 (five) years past experience in completion of similar works at Bank and its allied concern of minimum Tk.20.00 Lac in a single Tender. The intending Tenderers will have to purchase Tender document from the office of the undersigned by applying in their letterhead pad well ahead before the last date of tender selling along with the following documentary evidence:
 - a. Satisfactory documents evidencing their experience & specialization in respective fields along with past experience in completion of the related works.
 - b. Work experience & clients' list with detail address, contact person & telephone number.
 - c. Updated Trade License, VAT Registration Certificate, Up to date Income Tax Payment Certificate and Bank Solvency Certificate.
 - d. Satisfactory documents evidencing the contractor have either a B. Sc. Engineer having 3 years of works experience or a Diploma Engineer having 5 years of works experience.
3. **Place, time and availability of Tender Document:** Tender documents will be issued to the intending tenderers on cash payment of **Tk.2,000.00 (Taka Two thousand)** only (Non-refundable) for each document on all working days from the office of the undersigned during office hours from **November 09, 2017 to November 19, 2017**.
4. **Receiving & Opening Date & Time:** Tender alongwith other supporting documents will be received in the office of (i) REPED, 20 Dilkusha, 8th floor (ii) IBTRA, 13A/2A, Block – B, Babar Raod, Mohammadpur, Dhaka **upto 12:00 Noon on November 20, 2017** and will be opened at Yousuf Chambar, 20 Dilkusha, 9th floor **on the same day at 2:30 PM** in presence of Tenderer/representative(s) who may like to be present.
5. **Earnest Money:** 2.5% (two point five percent) of the total tender amount in favour of Islami Bank Bangladesh Limited in the form of Bank Draft/Pay Order from any Schedule Bank preferably any Branch of Islami Bank Bangladesh Limited must be submitted along with the tender without which the Tender shall be rejected outright.
