

NOTICE INVITING RE-TENDER

ISLAMI BANK BANGLADESH LIMITED invites sealed Tenders from bonafide Bangladeshi Interior Contractor(s) having wide experience in Internal Construction and related works for performing of Internal construction and other related works under the following conditions:

1. **Name of work:** Internal Construction and other related works of proposed 6 (six) new branches of IBBL at Agrabad Commercial Area (Chittagong), Satkania (Chittagong), Alamdanga (Chuadanga), Chatmohar (Pabna), Fakirhat (Bagerhat), Hemayetpur (Dhaka) and repairing of store & arrangement of computer Lab of ICTW at Bank's own property at 196, Motijheel, Dhaka.
