ISLAMI BANK BANGLADESH LIMITED invites sealed Tenders from bonafide Bangladeshi Interior Contractor(s) having wide experience in Internal Construction and related works for performing of Internal construction and other related works under the following conditions:

1. **Name of work:** Internal Construction and other related works of Proposed 10 (Ten) new branches at Madhukhali (Faridpur), Kaligonj (Keranigonj, Dhaka), Palashbari (Gaibandha), Fulgazi (Feni), Ranirhat (Chattogram), Fulbari (Dinajpur), Bagha (Rajshahi), Moheshpur (Jhenaidah), Sakhipur (Tangail), Kaliakair (Gazipur) and Internal construction & renovation works of Dhap Branch, Rangpur, Internal construction, Shifting & other related works of Konabari Branch, Gazipur & Keshorhat Branch, Rajshahi.
