1. **Name of work:** Internal Construction and other related works of Proposed 10 (Ten) new branches at Ashkar Dighir Par (Chattogram), Dhunot (Bogura), Islampur (Jamalpur), Sarail (Brahmanbaria), Bonpara (Natore), Shibpur (Narshingdi), Fulbari Gate (Khulna), Shibchar (Madaripur), Chunarughat (Habigonj), Bhujpur (Chattogram) and Interior Decoration, renovation & other related works of Chandpur Branch, Chandpur.
